Our readings this week reflect on the nature and aims of Christian Marriage. Essential to the celebration of marriage is the presumption that a husband and wife are committing to a union which will be **faithful, fruitful, and final**. This is a tall order for a world that values individual liberty and expression above loyalty to others, self-realization and self-actualization over self-sacrifice, and keeping one's options 'open' for the inevitable eventualities of life, rather than embracing one's commitments. Indeed the demand upon the Church to investigate the validity of broken marriages in its tribunals is an indicator of the degree of the brokenness of our culture ('hardness of hearts') that Jesus speaks of in the Gospel.

The Church jealously guards and defends the marriage bond, and expects the faithful who have entered into marriage to honor those vows unto death of one of the partners. Simply stated, a valid marriage bond which is formed cannot be broken by any divorce or even by any Church tribunal. For those whose marriages have suffered divorce, there is often some confusion about one's status within the Church. For the sake of clarity in these teachings:

* **Civil divorce** often results from serious sin within or around a marital relationship, and the circumstances of that divorce should properly be dealt with in the confessional, as one would do with any other serious sin. However, because divorce is not recognized by the Church as the dissolution of a marital union, as long as the divorced party does not attempt another marriage (in or out of the Church) and is otherwise 'properly disposed', this person may participate fully in the sacramental life of the Church, including receiving Holy Communion.

* **Remarriage** after divorce (while a former spouse is still living) without recourse to the Church to resolve the validity of the prior union, places a person in an objective state of adultery, which is a grave sin. Unlike a normal 'mortal sin' confessed in sacramental confession, one finds themselves in an enduring state of sin following 're-marriage'. Here the conditions of reconciliation (the renunciation of an 'adulterous' relationship) are usually not present. One is normally not free to receive Holy Communion while in this state.

* **Remarriage following an "Annulment"**: A person can be free to attempt marriage in the Church again and live the full sacramental life of the Church following a failed union if the prior union lacked *from its beginning* one or more properties of a true Christian marriage. When the Church examines these marriages to consider granting a 'declaration of nullity', the intention is not to assign blame, but rather to determine, *in justice*, if an attempted union was less than a true sacramental marriage. An invalid union can result from any one of a number of defects: fraud, simulation, an intention against the essential properties of marriage, a grave psychic disorder, or some other defect on part of the persons involved or the celebration of marriage itself. In no case should an 'annulment' be considered "Catholic Divorce". The burden of proof is upon the petitioner to demonstrate that, at the time of the marriage, a serious defect existed that prevented the attempted union from being authentic Christian marriage.

Children born to a union later declared null by the Church are not in any way to be considered 'illegitimate'. Indeed, children of divorced parents need special care on part of both of their parents to insure that the circumstances of their parent's break up does not pre-dispose them to divorce in their own marriages later in life. Children bear deep wounds that divorcing parents need to be aware of. Divorced parents have a special responsibility for living their lives in exemplary Christian witness which includes respect the child's other parent, judicious and restrained efforts in courtship (which must be absolutely honorable with respect to the duty towards marital chastity), and consideration of the challenges facing children who find themselves entering into a 'mixed family' situation. The natural obligations a parent has to a child of a previous union need to be paramount over any ambition a parent has towards pursuing a subsequent marital union.

In the parish office, we are able to assist those who are in need of presenting a case to the marriage tribunal in the diocese. For many this is an opportunity to return to the sacramental life of the Church and to enter more deeply into healing from a failed attempt at marriage.

* **Death of a Former Spouse**: If one's spouse from a previous marriage is deceased, (and, the spouse did not cause the death) the bond of marriage is broken, permitting a new marriage to be recognized by the Church. Persons who plan to marry after the death of a spouse simply follow the process of any other Catholic preparing for marriage. On the other hand, persons who perhaps have remarried during the lifetime of a former spouse who has since died should present themselves in the parish office to learn how to go about having their current marriage recognized by the Church. In any case, if there are questions about one's marriage in the Church, please call the parish office to discuss your situation. For many this is an issue that causes great consternation and leads some to abandon their faith. This need not be so. We stand ready to assist.


